I will always provide a written quote and will request that this is accepted in writing before starting work.

I reserve the right to alter the price if too many changes have been requested within the price and time allowed for the work, but I will always notify you if I believe this is likely to happen and will not undertake any more work before you have understood and accepted the changes in cost and timescale.

# If alterations to original art are required

I will send a photograph (which will be watermarked) of the finished artwork for your approval. If any changes are needed they will be done at this stage, until you are happy with your picture, but as my work is priced very reasonably, I reserve the right to refuse to make significant changes free of charge if I believe too much time will be involved. If you require changes to your drawing after you have received it, you must contact me within 7 days of receipt. The drawing must be returned at your cost in its original packaging. If your drawing is damaged in transit, please photograph the packaging immediately and return it to me in the original packaging (at your cost), and I will redo the portrait at no further cost. The time it takes to complete the drawing will be dependent on the other commissions I have at the time.
